Research methodology

Sampling

The survey was conducted by international research agency Glocalities. The sample in France was provided by fieldwork provider Dynata, the world's largest first-party data and insights platform.

Fieldwork

The fieldwork was part of the annual Glocalities survey that was conducted online between 19 February 2021 and 12 March 2021. In France, there were 1053 respondents that participated.

Language

The questionnaire was translated into French by professional translators and participants answered the questionnaire in French.

Quota and weighting

Prior to the data collection quotas for age, education, gender and region were set up, according to the most recent Census data in France. The sample is weighted according to census data for age, gender, region, education and voting behaviour (latest national elections). The survey for France generated nationally representative samples with respect to age (18-70), gender, region and education. A survey with an unweighted probability sample of this size and a 100% response rate has an estimated margin of error of +/-3.1 percentage points at a 95-confidence level. This means we can say with 95% confidence the results we found are somewhere between -3,1% and +3,1% of what we find if we were to repeat the study.
